

**ORDER OF ELECTION FOR THE HAMILTON COUNTY HOSPITAL
DISTRICT BOARD OF DIRECTORS**

THE HAMILTON COUNTY HOSPITAL DISTRICT BOARD OF DIRECTORS

CALL for an election to be held on the first Saturday in May, which is May 1, 2021 for the purpose of electing two seats on said Board.

TERM OF OFFICE for said seats is to be for a period of two years. Two directors' seats shall be elected for District Precinct number One and for one director's seat District At Large.

POLLING PLACE ON ELECTION DAY by personal appearance shall be Hamilton County City Hall lobby.

JUDGES: Election judge on Election Day shall be __to be announced__, Alternate Judge shall be _to be announced_ and Election Clerk shall be _to be announced_.

EARLY/ABSENTEE VOTING by personal appearance to be held at:
Hamilton General Hospital, 400 North Brown Hamilton, TX 76531, Monday through Friday 8:00 AM to 5:00 PM, April 19, 2021 until April 27, 2021.

EARLY/ABSENTEE VOTING BY MAIL-IN BALLOT:
Request for application for mail-in ballot may be obtained at Hamilton General Hospital, from 8:00 AM to 5:00 PM Monday through Friday thru April 20, 2021.

Mail-in ballot must be received by mail no later than May 1, 2021 at 7:00 PM.

CANDIDATES: Candidates wishing to file for a seat on the Hamilton General Hospital Board of Directors must turn in an application.

APPLICATION:

1. A person wishing to have his/her name printed on the ballot as a candidate must file the application with the Secretary of the Board, Jordyn Powers, no later than February 12, 2021 at 5:00 P.M.
2. An application for a write-in candidate must be filed with the Secretary of the Board, Jordyn Powers, no later than February 12, 2021 at 5:00 PM.

3. The application must specify the District precinct the candidate wishes to represent, OR specify that the candidate wishes to represent the District At Large.

QUALIFICATIONS FOR OFFICE: To be eligible as a candidate, a person must be:

1. A resident of the Hamilton County Hospital District
2. A resident of the district precinct the person wishes to represent, AND
3. A qualified voter


